SEKISUI KASEI CO., LTD. (Head Office: 2-4-4 Nishi-tenma, Kita-ku, Osaka; President: Masato Kashiwabara) has been promoting the introduction of solar power generation systems throughout SEKISUI KASEI Group. We have newly installed new solar power generation systems at four of our sites: Sekisui Kasei Kanto (Shimodate), Sekisui Kasei Saitama, and Sekisui Kasei Toubu (Head office and Kanuma), and have begun generating electricity.

## New Solar Power Generation Systems Installed at Four Sites

## 1. Background

SEKISUI KASEI Group has set a goal of reducing Scope1+ $2^{*1}$  CO<sub>2</sub> emissions by 27% compared to FY2018 by 2030 and achieving virtually zero CO<sub>2</sub> emissions by 2050, to achieve carbon neutrality. To achieve this goal, we are promoting the introduction of equipment to switch energy used in production activities from fossil fuels to renewable energies.

## 2. Overview

We have installed new solar power generation systems at four of our sites: Sekisui Kasei Kanto (Shimodate), Sekisui Kasei Saitama, and Sekisui Kasei Toubu (Head office and Kanuma). Each site will use the electricity generated for its own consumption. As a result, 7 out of 52 sites of 18 Group companies in Japan have already installed solar power generation systems, and we plan to install the systems at 3 more sites as well as expand the number at existing sites in the current mid-term management plan (through FY2024). In addition to reducing our own emissions, the systems will also contribute to the stable supply of electricity to plants and local communities and to the promotion of carbon neutrality.
